



Terms and Conditions

Utnarm 2020

When submitting this final registration, you accept the following terms.

The following dates apply when registering to Utnarm 2020:

Initial registration - 2020-05-06 to 2020-06-12

Registration is binding - 2020-06-19

Complete registration - 2020-08-10 to 2020-09-04

Definitions

Utnarm is in this agreement called the organizer and the registrator is called the exhibitor.

Jexpo is the registration system.

Goods (if applicable)

It is the exhibitor's responsibility that potential goods stored in the goods reception do not arrive before 2020-11-02, unless agreed upon with the organizer. The goods reception is open:

Monday 2020-11-02 - 8:00-18:00

Tuesday 2020-11-03 - 8:00-18:00

Wednesday 2020-11-04 - 8:00-20:00

It is the exhibitor's responsibility that all goods stored in the goods reception are picked up before 12:00 the day after the fair 2020-11-06, unless other arrangements have been made with the organizer. The exhibitor is to pay an administrative fee of 500 SEK per day that goods are stored before or after the fair outside of above dates.

Information and marketing

The exhibitor is responsible to provide information and material for the exhibitor catalogue and marketing before 2020-09-04, when the complete registration closes. If the material is not sent in the right format or not in time, the organizer has the right to exclude it from the exhibitor catalogue.

The exhibitor is responsible for creating a virtual booth on Graduateland with information and material before 2020-10-26 and putting it online. If this is not done on time the organizer has the right to exclude the company from the virtual fair. You are strongly recommended to set up your booth and put it online before October 1st for maximum exposure.

Payment

Payment is made within 30 days of the invoice being issued, unless otherwise agreed with the organizer. Detailed prices will be published on www.utnarm.se. The organizer has the right to withdraw the price of the base kit for the fair (12,000 SEK) in advance. The exhibitor can choose to be invoiced with e-invoice in the registration and if the exhibitor chooses this billing option then the exhibitor is responsible for ensuring that the e-mail address stated is correct. The exhibitor is responsible for ensuring that the invoice enters the internal system.

If the exhibitor chooses to be invoiced with a paper invoice, the exhibitor assures that the billing address stated is correct. An administrative fee of 30 SEK will be added if the exhibitor chooses to be invoiced with a paper invoice. If the billing address is changed after the fair day, 2020-11-05, without the organizer being notified or if the specified email address for the e-invoice is wrong, the exhibitor will be charged with a fee of 50 SEK.

Late payment

If the payment is not received before the due date, interest will be applied in accordance with the Interest Act. The exhibitor is charged an administrative fee of 45 SEK if a reminder invoice is sent out by mail.

Covid-19

The fair, events and contact talks will be executed according to the Covid-19 regulations.

If an event is cancelled because of regulations and can not be executed in a satisfying way for the exhibitor and the students, the event will be cancelled free of charge.

Exposure packages

Application for exposure packages is an interest application and is not binding until approved by the exhibitor in Jexpo.

Events and Contact talks

Application for events and contact talks is an application of interest and you will be contacted by the event managers to create an event you are happy with. The application is binding when a separate deal is signed or when the order is approved by the exhibitor at Jexpo. Thereafter, the exhibitor will be charged full price if the service is cancelled.

If the organizer considers that there is no possibility for contact talks in person, the organizer will notify this before 2020-10-01 and the contact talks will only be held online instead.

Cancellation

If the exhibitor is to cancel the registration, the following applies:

Cancellation after 2020-08-09 – full base kit is charged. 12 000 SEK

The application of additional services is legally binding when a separate deal is signed or when the order is approved by the exhibitor at Jexpo.

Force Majeure

Is the performance of the contract significantly impeded as a result of external circumstances beyond the scope of the parties, such as measures taken by public authorities, war, mobilization, enhanced defence preparedness, fire, labor shortage, labor dispute, natural disaster, adverse weather conditions, bankruptcy, any party may, if it can be assumed that the aggravating circumstance is not of a temporary nature, withdraw from the contract without liability. Party wishing to withdraw from the agreement shall inform the other party in writing without reasonable delay after the aggravating circumstance has become known to him.

Disputes

Disputes related to this agreement will be settled by the Swedish court according to Swedish law.
